A = OLD BUSINESS

Waived reading of the prior minutes.

B = NEW & ONGOING BUSINESS

- 1) The Board's received one preliminary estimate for **repairs to the rock wall** on our perimeter with Bedford Road but will research other contractors. We have the names of 4 other masons.
- 2) A strong letter was sent to the woman on Brentwood Dr. who walks her **dog** and doesn't pick up after it.
- 3) The replacement of the **basement doors and windows** is complete in Fox 1 & 3, Fox 2 is 85% complete.
- 4) The proposal to convert to **LED lighting** on the buildings is in and we are examining it and financing. The job will pay for itself in 21 months and then it will be 57% more efficient.
- 5) We will be repairing cracks & potholes in the **parking lots** & painting the lines too, in the not to distant future.
- 6) **Basement storage** bins are being painted upon vacancies. Let us know if you'd like yours done too.
- 7) Karen Martin will quarterback the **building representative system**, she will also re-institute the welcome package for new owners. Each building ideally will have a representative to the board, other than a board member.
- 8) Carey & Walsh **plumbing & heating** will begin upgrades to 4 of our heating systems as a test, 2 in each of Fox 2 & 3; one was done with Fox 1's recent installation of the new burner.
- 9) We will install **curbs on Campus Dr.** and landscaping shortly thereafter. This will be a big enhancement to that entrance at little cost. The curb at 64 Foxwood will be cut back at the **Copper Beech tree** at the same time.
- 10) **Dryer vents** will be cleaned throughout all of Foxwood this fall, **gutters** too. **Storm drains** will be examined.
- 11) A majority of the **tree stumps** were removed.
- 12) We continue working with **Toll Brothers**, who will be building 68 townhouse units behind us on Washington Ave., on screening & privacy issues on our border.
- 13) We have locked our **oil price** at a very favorable rate after following prices closely. We hope to see big savings here. Our **electric rates** were locked with an option to re-lock at our sole election.
- 14) Please note that **FHA meetings** (always the 2nd Tuesday of every month, except election season) will now be at 7:30. If there is a prior forum, it will start at 7:30 and the meeting will start immediately thereafter.
